

# **Dorcas Privacy Statement**

Dorcas uses personal data only for the purpose for which you have provided it, thereby complying with privacy legislation.

### What is personal data?

Personal data are data that can be traced back to an individual, such as names, addresses and places of residence (NAP). Email addresses and donations provided, in combination with NAP data, are also considered personal data.

#### How does Dorcas obtain personal data?

For all processing of personal data, only the data that you have provided yourself or that have come into our possession in another way are used, such as your bank account number when you transfer money to Dorcas. If you move and do not inform us, we will try to find your new address. All data will be treated confidentially. Personal data will only be released with your explicit permission. Your personal data will not be made available to third parties without your permission, unless we are legally obliged to do so.

Dorcas may ask for your location data on mobile devices. These data are only used to best serve you in providing information and are only used when you have given your consent.

You decide which data is made available to whom. If profiles are kept, they are used exclusively to tailor our services to the users's needs and will be communicated in advance.

#### What does Dorcas do with obtained personal data?

Dorcas uses your personal data only for the purpose for which you have given it. We guarantee that your data will not be used for purposes other than providing information and increasing your involvement in Dorcas projects. This means that Dorcas does not use your data for purposes other than those mentioned.

## How long does Dorcas keep personal data?

Dorcas stores personal data according to the legal retention period.
